PSSP-MER Board of Directors has ascertained that a number of new member applicants to the society are not adequately prepared and ready to meet the knowledge and competence requirements of the safety profession. In order to maintain the society's established credibility and professionalism of having competent members, the Board of Directors has decided to ensure that all applicant members of the society should at least have enough safety knowledge acquired before they could claim membership in the society.

In this regard, the Board of Directors HAS RESOLVED that any new-member applicant be registered as **INTERIM MEMBER** and thus be issued an "Interim Member" certificate and ID while he/she is in the process of completing 40 Hours of society-provided continuing safety education. The 40-hours CSE can be attained by either completing the 40-hour BOSH Course or an accumulation of 40 hours from the regular Seminar Workshops provided by the society.

Upon completion of the required 40-hours society-provided continuing safety education, the Interim Member can then re-apply as an Associate Member. Upon approval of his "Associate" membership, he/she will be issued the new membership certificate and ID free of charge.


